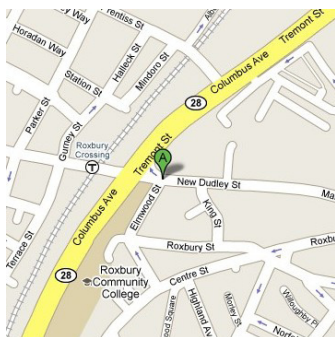

**DIRECTIONS FROM ROXBURY CROSSING STATION ON THE ORANGE LINE** At Roxbury Crossing take a right when leaving the station. Cross Tremont Street and the entrance Reggie Lewis Center is located at the intersection.

**DIRECTIONS BY BUS OR FROM DUDLEY SQUARE STATION IN ROXBURY** MBTA Bus routes 15, 22, 23, 28, 42, 44, 45, 66 all stop at Roxbury Crossing. From Dudley Square Station take any bus going towards Ruggles Station or Harvard Sq and get off at Roxbury Crossing
